Council inquired about Courtland's Town Associations position on this matter. The CTA representative said that they were unanimously in favor of the project.

Sally Shanks inquired about separate water and sewer services to each house. The applicant said that separate water existed. Separate sewer was being addressed.

Stan Eddy inquired about delays in the project moving forward, and the timing of the applicant's parcel map application. The applicant indicated that the project slow down has been due to delays in getting FEMA approval on the second and third houses. The first house was not subject to FEMA decertification regulations. However, the improvements on the second and third house have been determined to fall under FEMA regulations, as they have decided that the improvements exceed 50% of the value of the structures.

Chairman Labrie supported the applicant's response to Stan Eddy about the FEMA approval difficulties. He discussed the new problems being posed for existing property owners who want to improve existing structures. The regulations are

This is due, in part, to the extreme difficulty for property owners to determine the value of their structure (without the property included) to know at what point an upgrade project exceeds 50% criteria that would bring the FEMA regulations into play.

The result is that the FEMA decertification regulations are discouraging individuals wanting to upgrade their older residents from doing so.
