3. A Special Development Permit to allow:

• 12 lots to be served by a private drive;

• Reductions in minimum front yard setbacks for Lots 1, 5, 6, 9,

10, 11, and 12; and

• Reductions in minimum rear yard setbacks for Lots 3, 4, 5, and

6.

4. A **Design Review** to comply with the Countywide Design Guidelines.
