Action: County (Jessica) stated that the request is to recognize where the building comes to the right of way line which requires a special development permit. This request would establish formal entitlement which authorizes the building and any rebuilding which may be required in future would then be in compliance.

Applicant: Steve White stated that the entitlement was written into the purchase agreement by the previous property owner and that this is a unique circumstance which is as a result of the Hazel widening project. He confirmed that parking allotments will be acceptable under the proposed plan.

CPAC comments:

Robert Luscombe asked for clarification on where the sign would be moved. County/Applicant (Steve White) indicated on the provided map.

Rebecca Friedman, Secretary asked if the proposal was acceptable to property owner? The County/Applicant (Steve White) stated that it is, and they had already signed necessary documents.

Harry Azar, Chair disclosed that he was notified of this items as his home is within 500 feet of the property.

Harry Azar, Chair stated that it appeared that even before the Hazel widening project it appeared that there was less than a 50 feet setback. County (Jessica) clarified that it appears that this may have been considered to be the 25 foot setback with landscaping, making it in compliance.

Becky Wood asked if the County is covering costs on behalf of the owner? The County/Applicant (Steve White) confirmed they are.

Robert Luscombe asked how - already in progress work - The County (Jessica) stated the County already has possession

of easement rights and this is for compliance purposes.

Harry Azar, Chair asked about the purpose of the nearby sound wall and setback. County/Applicant, Steve White commented it is not on the current plan and is amended on the current documents.

Fruitwood Court update

County (Leanne) provided an update on an item previous heard by the Fair Oaks CPAC. She reported that the septic variance was approved and the Subdivision Review Committee approved the project on October 5, 2017. On October 13 neighbors appealed and requested a fee waiver. The fee (fee of \$4,065) waiver will need to be heard by the Board of Supervisors. It is scheduled to be heard at the December 5 Board of Supervisors meeting. The appeal hearing is requested for December 18 before the Planning Commission Hearing.
