Project Name: Lakeside Apartments Development Plan Review and Exception

Location: The property is located on the south side of Maritime Drive, 300 feet east of Harbor Point

Drive, in the Franklin-Laguna community.

Request: A Development Plan Review for 150 multifamily dwellings on 10 acres in the LC zone.

An Exception to allow two-story dwellings within 100 feet of a residential zone (proposed 25 feet away from adjacent residential zone), more than 8 attached dwellings within 100 feet of a residential zone (10 attached units proposed in each building cluster), a reduction in the setback for trash enclosures adjacent to the internal access drives (15 feet required and 2 feet proposed), and to allow garages to be located between 6 and 19 feet from private access drives (Zoning Code encourages either between

6 and 19 feet or 20 feet or more).

Note: The Zoning Code allows multifamily developments in the LC zone.
