- The Council is unclear if this subdivision is intended to connect the two neighborhoods or if Short Road will remain a dead end.
- Concerned that the zoning map shows this lot as roughly split in half between RD-2 and RD-4 zoning, which doesn't seem to coincide with the east property line of proposed Lots 11-13.
- Agree with the request for a time extension on this project.
