County Input:

 Most likely this project will be exempt from CEQA because of the small size and existing/proposed use doesn't change.

Applicant/Owner was represented by Kent Baker Surveyor/Engineer for the project. He presented the project and responded to questions:

- All three proposed parcels have separate power service presently.
- Currently all three parcels have one service for each: water, sewer, and gas. These services will be split so that each parcel has its own service.
- The large parcel currently is rented to a Hmong Church.
- The current owner plans to sell of all three parcels once the map is approved.
- It is believed that the Hmong Church will purchase the large parcel for their services.
- There are no exceptions required in this request and all setback requirements are met.
- The two smaller proposed parcels are quite a bit larger than the minimum size for RD-5 zoning.

Council comments and concerns:

- Will there be any effect to the local Hmong community on the sale of these properties? Probably not if they are able to purchase and continue to use the existing church.
- Traffic into and out of the church parcel and the close proximity to the intersection with 65th Street.
- Council was assured that the existing homes meet all requirements of setback to fences for side yards and back vards.
- The County should revisit putting in a traffic light controlled intersection at 65th Street and 53rd Avenue.

Neighborhood comments and concerns:

- Three neighbors attended the meeting.
- They all approved of the request as they all liked the idea of new home owners in the neighborhood for the two proposed smaller parcels with existing houses.

- The neighbors did have the following concerns.
- The existing two homes appear currently vacant and they have seen some people at times at the homes that may or may not have the right to enter the homes. Because of this they are concerned with potential use by squatters, homeless, drug use or other illegal activity.
- The church brings a lot of traffic to the area between Friday and Sunday for church services and other events.
- The church has had open burning on their property that has sent paper ash over the cars and homes in the neighborhood. One neighbor called the church and they stopped for a while then started again.
- There has been many accidents at the intersection of 53rd Avenue and 65th Street and they would like a signalized intersection to address the traffic situation.
- There is a charter school in the area and that has children walking the neighborhood and having to cross 65th Street.
