

CONSOLIDATED PLANNING ADOPTED APPLICATION FEE SCHEDULE (WITH SURCHARGES CALCULATED)

Instructions

Fees for Entitlements not in shading are based on time and materials (see Footnote a)

The following surcharges are added to each project:

1. \$155 to cover the cost of early notification (CPAC review)
2. IT Recovery fee of 4.5% , subject to a \$350 maximum. Not applicable to Appeals.
3. \$366 to cover the cost of posting the property ; \$90 for temporary mobile homes
4. \$473 to cover the cost of Fire District review (see footnote h)
5. Amendment and Renewal Fees/Deposits are 60% of the Fees/Deposits listed in this Schedule

Lines in White indicate entitlement types on a time and materials basis.

Note: The Planning/CEQA Entitlement column is a deposit amount while fees going to other departments and agencies are flat fees.

Lines in Yellow indicate entitlement types based on a flat fee.

NOTES:

(a) For projects billed on a time and materials basis, a Planning/CEQA Deposit will be collected and applied toward estimated project hours. The Applicant will be contacted once 80% of the deposit amount is expended to request an additional deposit.

Any Planning/CEQA costs over the deposit are invoiced to applicant. (Resolution 2010-0661)

In addition to the Planning /CEQA deposit, a one-time EMD CEQA fee in the amount of \$1,579 will be collected for those projects where EMD is the designated CEQA Lead Agency. (Ordinance SCC No. 1674)

(b) A charge of \$155 will be collected per application (not entitlement) to cover the cost of early notification.

(c) An IT Recovery Fee of 4.5% of the total application fee, subject to a \$350. maximum, will be collected on every new application. (Ordinance #SCC-1398)

(d) A charge of \$90 will be collected per application for a temporary mobile home (TMZ) to cover the cost of posting the property. For all other applications, a charge of \$366 will be collected per application (not entitlement) to cover the cost of posting the property. (Ordinance #SCC-1341)

(e) In the event an application is placed on hold or work cannot proceed due to inaction by the applicant for more than 360 days, the difference in original fees and current fees shall be paid at the time the application is re-activated.

(f) Planning Review: Base fee is \$158 for the first hour. Amount collected over the Base Fee is a deposit toward additional hours worked. Any costs over one hour are invoiced to applicant. (Resolution 2013-0574)

(g) The following entitlement types do not include a Fire District Review: ANS, APB, AWB, BLS, BRB, MAS, NCS, PAC, PAM, PCN, PRF, PSS, TSZ, TUZ, ZAZ and ZIP

(h) Fees are waived for urban agricultural stands meeting the criteria for a Temporary Use Permit

(i) MUP fees are waived for the incidental keeping of animals for Future Farmers of America, 4-H Club program or independent exhibitors
