





Background of the EJ Element

Office of Planning & Environmental Review




- Purpose is to address public health risks and environmental justice concerns.
- The County prepared a separate, standalone document that has the same weight as any other elements of the County's General Plan.
- There are 4 EJ Communities:
 - 1. North Highlands / Foothill Farms
 - 2. West Arden-Arcade
 - 3. North Vineyard
 - 4. South Sacramento

2024 Implementation Measure Update

Accomplishments

- Climate Action Plan
 - Approved by the Board of Supervisors on November 6th
- Transportation funding
 - DOT secured \$17.9 million in discretionary funds for projects in EJ areas
- Food System Assessment
 - Published by the Sacramento Food Policy Council back in November

In Progress

- Food Action Plan
 - In progress by Department of Public Health
- Grant seeking and applications
 - PER sought and applied for grants and won SACOG's Engage, Empower, and Implement (EEI) grant



 - And so much more...




