Warning----If the tree is located on a neighboring property, we will require a signed letter from the owner. The letter must include the following: (1) the neighbor's name, address, and phone number, (2) authorizing you, your name (or tree company name), your address and your phone number to trim or remove the tree in question, (3) include the tree(s) diameter, location, and any limitations or conditions, and (4) letter must be signed and dated.
